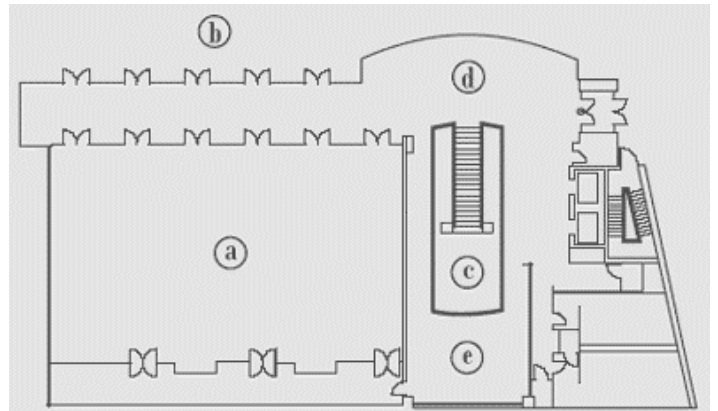

Below you will find the floor plans as provided by The Blackwell Inn and Pfahl Conference Center.

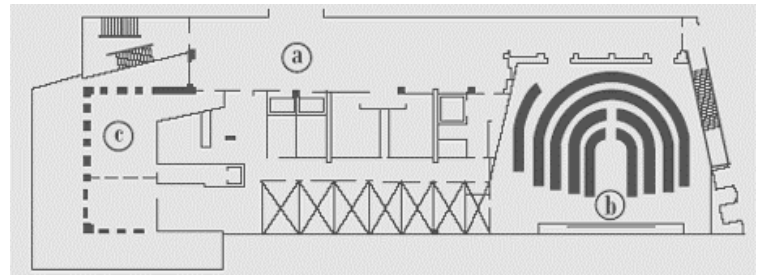
Galas and Gathering Plaza Level Floor plan

- e. Stadium view dining area



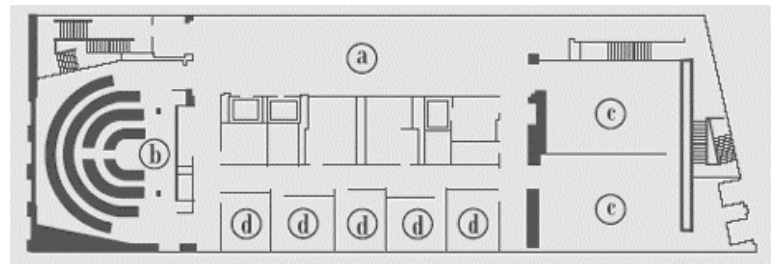
Pfahl Conference Center First Level Floor plan
